

## **SIME DARBY FOUNDATION SCHOLARSHIP FOR MASTER OF PUBLIC POLICY (MPP) PROGRAMME 2010/2011 SESSION**

*The International Institute of Public Policy and Management (INPUMA), University of Malaya is pleased to announce that the Sime Darby Foundation is offering four scholarships to public officials from Thailand and the Republic of Indonesia. These scholarships will apply to successful candidates for the Master of Public Policy (MPP) programme by coursework for the duration of 18 months.*

A candidate is eligible to apply only if he/she meets the following requirements:

- a. Must be a public official from Thailand and the Republic of Indonesia and has a minimum of 5 years working experience in the public sector.
- b. Must not be more than 40 years old.
- c. Possesses a minimum of a Bachelor's degree with a CGPA of not less than 3.0. Qualifications in the fields of administration, politics and economics will be an added advantage for prospective candidates.
- d. Must possess at least a score of 550 for a paper-based total or 213 for a computer-based total for the Test of English as a Foreign Language (TOEFL) or a band of 6 on the International English Testing System (IELTS).

### **AWARD**

The award covers:

- **Registration fees, course fees, examination fees and service fees.**
- **A monthly stipend of RM 1,200.00 for 18 months.**
- **A monthly accommodation allowance of RM 750.00 for 18 months.**
- **Books allowance of RM 1,000.00.**
